
Request for Contribution



VEDA RAKSHANA NIDHI TRUST (VRNT) is a Public Charitable Trust sponsored by Kanchi Kamakoti Peetam founded in 1963 under the guidance of His Holiness Sri Sri Chandrashekarendra Saraswati Swamigal.

Objects of the trust are preserving, protecting, promoting and disseminating Vedas in the traditional manner. VRNT has dedicated itself to preserving the uniqueness and distinctiveness of each branch of vedic recitation by encouraging students, scholars and practitioners in this noble endeavour.



The main activities of the Trust are:

- Hereditary Niyama Adhyayana Scheme (HNY): By this scheme VRNT encourages father teaching vedas to his son in a traditional method.
- Maintaining Veda Patasala for rare Veda sakhas
- Financial assistance to deserving Veda Patasalas on pan india basis
- Monitoring the vedic academic progress of affiliated Veda Patasalas by making yearly visits and conducting Varshika examinations of the students of all Patasalas across Tamilnadu, Kerala, Andhra Pradesh, Telengana, Maharastra and Assam
- Conducting final exams for students who have completed their course and awarding certificates and financial reward
